4098 Update

Over 660 or 80% of Primary ITO Workplace Assessors now hold Unit Standard 4098 Use standards to assess candidate Performance. A fantastic achievement considering in March 2020 just 25% of assessors held this unit. Congratulations to those of you who have gained US4098 over the last two years. Having our assessors upskilled has the dual benefit of improving assessor confidence and judgments while ensuring assessment for our learners is fair, valid and to the national standard.

The increase over the last two years is due to the uptake in enrolling to the PITO/Wintec 4098 courses offered nationally and training advisors following up with assessors regarding their assessment requirements for the course, so they can complete within the requisite 12 months or sooner. Moderation Update

Corrections Moderations are now completed for the year with a 100% compliance rate for assessors moderated in 2022. Prison visits for face-to-face and PD support days will resume in 2023.

The Arboriculture and Production Horticulture moderation is now completed. There has been a marked improvement of engagement with 90% of assessors being found compliant.

Thank you to those of you who submitted material for moderation this year. This is an important quality assurance process to give industry confidence that assessors are making consistent decisions about learner competency and to the National Standard.

A reminder: all assessors are obligated to participate in moderation activities when requested otherwise they may put their registration at risk.

Moderation of Enchem, Seafood and Sports Turf assessors is currently underway and progressing well. Results will be reported in the next issue.
