

Welcome to our final newsletter for 2023.

This year's moderation cycle is wrapping up with 69 programmes being moderated in 16 different Primary Industry sectors. Our moderation for 2024 will again be focussing on assessors within specific programmes of study. The programme-led approach we have followed this year is important- as well as giving assurance to Standard-Setting Bodies, learners, employers, and other stakeholders that our learners' competency is reliable, our moderation findings also inform assessment changes, programme revision, new qualification design and they also contribute to NZQA reviews.

The Government recently announced a review of the future state of Te Pūkenga. As Te Pūkenga works through the details of the steps required to give effect to the Government's expectations, the Academic Integrity team will continue to operate nationally, as we do at the moment, using the same approaches to moderation.

Unified programme moderation is likely to appear in 2024, and this will be added to our calendar as needed. Across Polytech's and ITO's there are many qualifications that currently have multiple programmes structured and delivered in various ways. Te Pūkenga is working to develop one 'unified' programme for each qualification that will support common delivery - the goal is that learners will be able to transfer seamlessly between Polytech's and ITO's.

### **Moderation Update**

This year our focus has been on moderating qualifications and the programmes they encompass. **69 programmes** and over **350-unique unit standards** will have been moderated by the end of 2023.

#### **Corrections**

2023 has seen prisons open to contractors again, so after a two-year hiatus, a number of onsite moderation clusters were held around the country for Corrections instructors and assessors. Over the past 2 years there has been a decline in the numbers of inmates in training, however this is expected to increase again over the next year or so.

The quality of work that comes from the prisons is very high, and assessors have a high compliance rate. There is a lot of instructor peersupport within the prison training, which gives integrity to the process.

#### Horticulture

Amenity, Landscape, Arboriculture, Sports Turf and Production Horticulture moderations have been completed and it is great to see a high compliance rate of 95% for learner samples moderated. This gives industry confidence that assessors are making consistent decisions about learner competency and to the National Standard.

Seafood and Cross Sector moderation is currently underway and progressing well with results in the next newsletter.

### **Programme Evaluations update**

Two Programme Review Self-Evaluations recently completed are:

New Zealand
Certificate
in Artificial
Insemination of
Livestock (Level 4)
was found to be an



effective programme that provides value for both graduates and their employers. Particularly effective was the very hands-on training which provides a logical progression from theory to mentored practice over a season. In 2022 the completion rate for all learners was 73% and was 85% for Māori learners.

The Micro-credential Safe Use of Chainsaws (Level 3) is a very popular programme with applications across a variety of sectors. It has a very high rate of Māori participation and achievement, and all learners in this programme are achieving at or above benchmarks. The short duration and workshop-based training model works well for employers and provides a valuable safety-focused skill set.
