The moderation team continues to see a consistently good standard of assessment across many sectors for 2025 Including in the recent Seafood, Rural Pest Operations and Apiculture moderations which had high compliance rates evident in our internal moderation These sectors were also externally moderated with the Muka Tangata Workforce Development Council with no significant issues to report. Viticulture Assessors also continue to perform well, receiving a 100% pass in a recent Workforce Development Council Moderation.





These results give industry confidence that assessors are making consistent decisions about learner competency and maintaining the National Standard.

It has been encouraging to see more descriptive assessor and verifier comments being used to tell the story about why the learner is competent and can repeatedly perform tasks to the required standard.
