# **Updated Requirements for Registered Assessors**

Please note recent changes to the following requirements:

#### Assessors must now report results to Primary ITO within 15 working days of assessment.

This is a change for 2024. As we are still a division under Te Pūkenga — New Zealand Institute of Skills and Technology (until government legislation is changed) we need to abide by Te Pukenga's academic framework and guidelines, which state that "all results are to be reported within 15 working days of the assessment being completed" as per our schedules in 2024 contracts.

New Assessors who don't hold 4098 - must now gain this unit standard within 6 months of enrolment to a course.



#### Also, a friendly reminder to:

**Safely store all completed learner assessments and supporting evidence for 24 months** in accordance with the Privacy Act (2020), **for the purposes of moderation** and to supply assessments for moderation within 15 working days.

# **Moderation Update**

## Seafood

Five programmes in seafood processing and deep-water commercial fishing were moderated with 94% of learner assessment samples moderated being found consistent with the national standard. Overall good assessment practice has been followed by assessors, with clear evidence and marking of answers apparent.



### Workforce Development Council Moderation

Primary ITO is receiving an increasing number of external moderation requests from the Muka Tangata and Hanga Aro Rau Workforce Development councils (WDC's). Depending on the unit standards requested this means that some Assessors may be asked on more than one occasion to supply moderation samples for the WDC - in addition to our own Primary ITO internal moderation requests. While this is unfortunate, it is necessary for the ITO to meet compliance requirements.

## **Programme Evaluations update**

Programme evaluations are internal reviews to gain a snapshot understanding of how our programmes are working in the field, how learners are achieving, how well they meet the needs of industry, and whether learning and assessment supports achievement.

## We recently reviewed our **Agriculture L3 and L4** programmes in Dairy Farming and Sheep/Beer/

**Deer farming**. In recent years these programmes have experienced some challenges since their release, including a move to online assessment using a new online learning platform - Mahi Tahi, concurrent with restrictions around COVID-19 affecting learning and assessment capability, and the changes in the farming sector and immigration regulations impacting how training takes place on-farm.

Despite this, graduates have gained the skills and knowledge they expected to, and these are benefiting both graduates and their employers. The qualifications are relevant to industry; however, this timely review has highlighted areas where the programmes can be improved, and this information will be used to inform both programme development and the upcoming review of qualifications with Muka Tangata.

## **NZQA Consistency Reviews**

In Quarter 4 of 2023, NZQA conducted consistency reviews of the following qualifications:

- 2467 Artificial Insemination of Livestock L4
- 4128, 2307, 2308 Energy and Chemical Operations L3, L4, and L5

These reviews act as a check to ensure that processes in organisations around the country support all ākonga (learners) who complete qualifications to meet the graduate profile outcomes, and that graduates' skill sets are consistent with each other. We are pleased to report that Primary ITO was successful in all of these reviews.
